This supplement (this "**Supplement**") to the Base Listing Particulars dated 2 May 2025 (as supplemented, the "**Base Listing Particulars**") comprises a supplementary listing particulars for the purposes of the Listing Rules of the Global Exchange Market and has been approved by The Irish Stock Exchange plc trading as Euronext Dublin ("**Euronext Dublin**"). Terms defined in the Base Listing Particulars have the same meanings when used in this Supplement.

This Supplement is supplemental to, and should be read in conjunction with, the Base Listing Particulars issued by Informa PLC (the "**Issuer**").

The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

Purpose of this Supplement

The purpose of this Supplement is to:

- (a) incorporate by reference into the Base Listing Particulars the Informa 2025 Full Year Results (as defined below);
- (b) following the publication of the Informa 2025 Full Year Results, update the statement of no significant change and no material adverse change;
- (c) following Informa's joint venture with Dubai World Trade Centre, update the section entitled "*History and Development of Informa*" of the Base Listing Particulars; and
- (d) following director changes, update the section entitled "*Management and Employees*" of the Base Listing Particulars.

Incorporation of Information by Reference

By virtue of this Supplement, the following sections of the announcement entitled "*Informa Group 2025 Full Year Results*" (the "**Informa 2025 Full Year Results**"), which was published via the regulatory news service of the London Stock Exchange plc on 12 March 2026 and has been filed with Euronext Dublin:

- (a) the tables entitled "*2025 Financial Summary*" and "*2025 Divisional Highlights*" (along with the accompanying notes) on page 3;
 - (b) the section entitled "*Financial Review*" on pages 6 to 14;
 - (c) the consolidated financial statements for the year ended 31 December 2025 (including the notes thereto), which are derived from the audited consolidated financial statements for the year ended 31 December 2025 on pages 15 to 38; and
 - (d) the section entitled "*Glossary of Terms: Alternative Performance Measures*" on pages 39 to 41,
- shall be incorporated in, and form part of, the Base Listing Particulars.

A copy of the information which is incorporated by reference in the Base Listing Particulars can be obtained from the website of the Issuer at www.informa.com.

If a document which is incorporated by reference in the Base Listing Particulars by virtue of this Supplement itself incorporates any information or other documents therein, either expressly or implicitly, such information or other documents will not form part of the Base Listing Particulars except where such information or other documents are specifically incorporated by reference in, or attached to, the Base Listing Particulars by virtue of this Supplement or the Base Listing Particulars. Where only certain sections of documents referred to above are incorporated by reference, the parts of the documents which are not incorporated by reference in the Base Listing Particulars are either not relevant to investors or are covered elsewhere in the Base Listing Particulars as amended by this Supplement.

Significant or Material Change

Under the section entitled "*General Information*" on page 111 of the Base Listing Particulars, paragraph 5 will be deleted in its entirety and replaced with:

- "4. There has been no material adverse change in the prospects of the Issuer or the Group since 31 December 2025. There has been no significant change in the financial or trading positions of the Issuer or the Group, since 31 December 2025."

History and Development of Informa

At the end of the section entitled "*History and Development of Informa*" on pages 92 to 95 of the Base Listing Particulars the following shall be added:

"On 19 January 2026 the Issuer completed its partnership with the Dubai World Trade Centre ("**DWTC**") through the launch of a new business, inD (pronounced "indee"). This business combines the Issuer's wholly owned B2B Live Events business in the IMEA region (India, Middle East and Africa) with DWTC's Dubai-based B2B live events business. The Issuer owns 52 per cent. and DWTC owns 48 per cent. of inD, with inD's revenues and operating profits fully consolidated within Informa financial accounts."

Management and Employees

In the section entitled "*Management and Employees – Directors of the Issuer*" on pages 100 to 103 of the Base Listing Particulars the row beginning "Patrick Martell" in the table and the section entitled "Patrick Martell" beneath the table shall be deleted.

Other Information

To the extent that there is any inconsistency between any statement in or incorporated by reference in the Base Listing Particulars by virtue of this Supplement and any other statement in or incorporated by

reference in the Base Listing Particulars, the statements in or incorporated by reference in the Base Listing Particulars by virtue of this Supplement will prevail.

Save as disclosed in this Supplement, there has been: (1) no significant change affecting any matter contained in the Base Listing Particulars (as supplemented at the date hereof) since the publication of the Base Listing Particulars; or (2) no significant new matter which has arisen, the inclusion of information in respect of which would have been so required had it arisen at the time the Base Listing Particulars was prepared.
