This document is a series memorandum (the "Series Memorandum"), which contains information relating to the above notes (the "Notes") issued by SPIRE acting in respect of its Compartment 2020-61 (the "Issuer"). This Series Memorandum should be read in conjunction with all documents which are incorporated by reference in the "Documents Incorporated by Reference" section herein, including the relevant sections of the base listing particulars dated 3 April 2019 and the supplemental base listing particulars dated 2 August 2019, which together constitute base listing particulars (the "Base Listing Particulars") relating to the Secured Note Programme (the "Programme") of SPIRE. Unless defined herein, terms defined in the Base Listing Particulars have the same meanings in this Series Memorandum.

This Series Memorandum is not an advertisement and neither it nor the Pricing Terms contained in this Series Memorandum constitutes a prospectus or final terms for the purposes of Regulation (EU) 2017/1129 (the "Prospectus Regulation").

The Issuer is not offering the Notes in any jurisdiction in circumstances which would require a prospectus pursuant to the Prospectus Regulation. Nor is any person authorised to make such an offer of the Notes on behalf of the Issuer in any jurisdiction.

Application has been made to The Irish Stock Exchange plc, trading as Euronext Dublin ("Euronext Dublin") for the Notes to be admitted to the Official List of Euronext Dublin (the "Official List") and to trading on its Global Exchange Market ("GEM"). This Series Memorandum constitutes listing particulars for the purpose of such application and has been approved by Euronext Dublin. GEM is not a regulated market for the purpose of Directive 2014/65/EU of the European Parliament and of the Council on markets in financial instruments (as amended, "MiFID II").

References in this Series Memorandum to Notes being "listed" (and all related references) shall mean that such Notes have been admitted to trading on GEM and have been admitted to the Official List. There can be no assurance that any such listing will be maintained.

The Notes are not rated.

#### **RISK FACTORS**

In respect of this Series only, the risk factors set out below should be read in addition to those set out in pages 4 to 37 of the Supplemental Base Listing Particulars (as defined in the section titled "Documents Incorporated by Reference" below) and, in the event of any inconsistency, the risk factors set out below will prevail.

# (a) Various unpredictable factors may affect the performance of equity indices

Equity indices are comprised of a synthetic portfolio of shares, and as such, the performance of an Index is dependent upon the macroeconomic factors relating to the shares that underlie such Index, such as interest and price levels on the capital markets, currency developments, political factors as well as company-specific factors such as earnings position, market position, risk situation, shareholder structure and distribution policy, as well as the index composition, which may change over time.

# (b) Actions by the index sponsor may negatively affect the Notes

The sponsor of the Index will have no involvement in the offer and sale of the Notes and will have no obligation to a holder of Notes. For example, the sponsor can add, delete or substitute the components of an index at its discretion, and may also alter the methodology used to calculate the level of the Index. The sponsor may also alter, discontinue or suspend calculation or dissemination of the Index. Any of these actions may have a detrimental impact on the level of the Index, which in turn could have a negative impact on the value of and return on the Notes.

# (c) Noteholders may receive a lower return on Notes linked to equity Indices than if they held the underlying shares directly

The value of and return on the Notes that depend on the performance of one or more equity Indices may be less than the value of and return on a direct holding of the shares of the companies comprising the components of the Index. This is because the closing index level on any specified valuation date may reflect the prices of such index components without taking into account any dividend payments on those component shares. Accordingly, Noteholders may receive a lower return on the Notes linked to one or more equity Indices than it would have received had it invested directly in those shares.

# (d) The occurrence of an index adjustment event or the replacement of the index sponsor by a successor index sponsor may have a negative effect on the Notes

If the sponsor of an Index makes a material alteration to the Index or cancels the Index and no successor exists, or if the sponsor fails to calculate and announce the Index, the Calculation Agent shall replace the Index with another index. Any such action may have a negative effect on the value and return on the Notes.

If the Calculation Agent believes that the proposed action above would not achieve a commercially reasonable result, the Issuer may redeem the Notes early. In such event, the Issuer will pay to the Noteholders the early redemption amount. The early redemption amount amount may be less than the original investment and Noteholders may lose some or all of their money.

If an index is calculated by a successor index sponsor, or, is replaced by a successor index, the successor index or index as calculated by the successor index sponsor, will be deemed to be the index if approved by the Calculation Agent. Any such successor index may perform poorly and may result in holders of Notes receiving less than they otherwise expected.

Any of these events may have a negative effect on the value of and return on the Notes.

# (e) There are additional risks in relation to Notes linked to exchange traded futures and options contracts on underlying indices

The Notes depend on the performance of exchange traded futures and options contracts on one or more indices (the "Relevant Underlyings"), and accordingly Noteholders are exposed to the performance of the Relevant Underlying which, in turn, will be driven by the level of the underlying Index.

There will be a correlation between the level of an Index and the price at which the Relevant Underlying on the relevant futures or options exchange, and they will therefore be exposed to the performance of the Index.

However, Noteholders should also be aware that the expectations of dealers in the Relevant Underlying of the level of the Index on the date(s) on which the settlement amount of an Index is determined may also have an impact on the price of the Relevant Underlying on the Index. For example, if the expectation of dealers in options contracts is that the level of the Index will be lower on a future date when the settlement amount of the options contract is to be determined than the current level of the Index, this may result in the price of the options contract falling (in the case of a call option) or rising (in the case of a put option) even where the current level of the Index is rising. Moreover, because the settlement amount of many options contracts is a multiple of the difference between the level of the Index on a future date and the strike, a relatively small change in the level of an Index may result in a proportionately much larger change in the price of the options contract.

If the expectation of dealers in futures contracts is that the settlement price of the Index on the date(s) on which the settlement amount of the futures contract is determined will be lower than the forward price of the Index specified in the contract, this may result in the price of the futures contract falling (in the case of buyers of the futures contract) or rising (in the case of sellers of the futures contract) even where the current level of the Index is rising. Moreover, because the settlement amount of many futures contracts is a multiple of the difference between the settlement price and the forward price, a relatively small change in the level of an Index may result in a proportionately much larger change in the price of the futures contract.
