RISK FACTORS

In these Risk factors, references to "Notes" should be construed as references to the Existing Notes and the Notes being issued hereunder collectively.

Investor Suitability

The purchase of the Notes involves substantial risks. Each prospective purchaser of the Notes should be familiar with instruments having characteristics similar to the Notes and should fully understand the terms of the Notes and the nature and extent of its exposure to risk of loss.

Before making an investment decision, prospective purchasers of the Notes should conduct such independent investigation and analysis regarding the Issuer, the Swap Counterparty and all other relevant persons and such market and economic factors as they deem appropriate to evaluate the merits and risks of an investment in the Notes. In particular, as part of such independent investigation and analysis, prospective purchasers of the Notes should consider carefully all the information set forth in this Series Memorandum and the considerations set forth below. However, it must be understood that the considerations set forth below are not, and cannot be, an exhaustive list of all possible risks associated with an investment in the Notes.

Investment in the Notes is only suitable for investors who have the knowledge and experience in financial and business matters necessary to enable them to evaluate the information contained in this Series Memorandum and the merits and risks of an investment in the Notes in the context of their own financial circumstances and investment objectives.

No secondary market for the Notes currently exists, nor is one expected to develop. Prospective purchasers of the Notes should therefore recognise that they may not be able to make any transfer of the Notes for a substantial period of time, if at all. Investment in the Notes is therefore only suitable for investors who are capable of bearing the economic risk of an investment in the Notes until their Maturity Date and are not acquiring the Notes with a view to a potential resale, distribution or other disposition at some future date.

References in this section of the Series Memorandum to "**UBS**" shall be deemed to be references to UBS AG, London Branch and any relevant affiliate, whether acting in any capacity in relation to the Notes or otherwise.

Credit Risk

The Notes will constitute secured, limited recourse obligations of the Issuer, recourse in respect of which will, in effect, be limited to the proceeds of the Mortgaged Property (as

defined herein and in the 2017 Programme Memorandum) relating to the Notes and no other assets of the Issuer will be available to satisfy claims of Noteholders.

Noteholders assume the credit risk of the Swap Counterparty (see also "*Exposure to UBS AG*" below) and may in certain circumstances assume the credit risk of the Collateral Assets (as defined in this Series Memorandum).

Swap Counterparty Replacement Option is applicable and consequently, UBS AG may not be the Swap Counterparty for the whole life of the Notes. However, each Replacement Swap Counterparty is required to satisfy certain eligibility criteria as more particularly set out herein.

None of the Issuer, the Trustee, UBS, the Custodian, the Principal Paying Agent, the Registrar nor any other person on their behalf has made any investigation of, or makes any representation or warranty, express or implied, as to (i) the existence or financial or other condition of the Mortgaged Property or (ii) whether the Charged Agreement constitutes legal, valid and binding obligations of the Swap Counterparty. None of the Issuer, the Trustee, UBS nor any other person acting on their behalf has, in connection with the Notes, made any investigation of, or makes any representation or warranty, express or implied, whether the Collateral Obligations constitute legal, valid and binding obligations of their issuers. The Issuer, the Trustee, UBS, their affiliates nor any other person acting on their behalf is not responsible for the public disclosure of information by any issuer of Collateral Obligations.

Investment in the Notes may involve a loss of principal by virtue of the terms of the Notes even where there is no default by the Issuer. Noteholders, and prospective purchasers of Notes, will at all times be solely responsible for making their own independent appraisal of, and investigation into, the business, financial condition, prospects, creditworthiness, status and affairs of the obligor(s) of the Collateral Obligations and the Swap Counterparty. None of the Issuer, the Trustee, UBS nor any other acting person on their behalf will have any responsibility or duty to make any such investigations, to keep any such matters under review, to provide the Noteholders, or prospective purchasers of the Notes, with any information in relation to such matters or to advise as to the attendant risks.

None of the Issuer, the Trustee, UBS, the Custodian, the Principal Paying Agent, the Registrar, their affiliates nor any other person acting on their behalf makes any representation as to the future performance of the Notes either in absolute terms or relative to other investments.

Rebalancing of Collateral Assets

The Terms of the Notes provide that the Collateral Assets (being the assets comprised in the Charged Assets for this Series of Notes) may or, in certain circumstances, shall be substituted (a "Substitution") or released (a "Release") from time to time in whole or in part. A Substitution or a Release is subject to the satisfaction of certain conditions relating to the market value (determined by the Calculation Agent in a commercially reasonable manner) of the Collateral Assets relative to the sum of the outstanding Aggregate Nominal Amount of the Notes and the satisfaction of certain eligibility criteria with respect to any assets to be included in the Charged Assets. Those conditions and criteria (which apply to the initial Charged Assets as well as to any Substitution or Release at any time during the life of the Notes) are more particularly set out in this Series Memorandum.

The selection of assets to be comprised in or to be removed from the Charged Assets shall be made by UBS in its capacity as Swap Counterparty. Subject to compliance with the conditions and criteria mentioned above, any such selection shall be made by the Swap Counterparty in

its sole and absolute discretion and the Swap Counterparty is not required to, and will not, take into account the interests of the Noteholders in so doing.

Collateral Assets comprised of cash

Investors should note that any Eligible Cash Collateral comprised in the Charged Assets will be credited to the Collateral Account, and any cash proceeds received by the Custodian on behalf of the Issuer in respect of its holding of Charged Assets will be credited to the Collateral Account pending any payment of such amounts in accordance with the Custody Agreement. Any money credited to the Collateral Account (whether Eligible Cash Collateral or cash proceeds in respect of the Charged Assets) is held by the Custodian as banker and not as trustee and as a result such money will not be held in accordance with the Financial Services Authority's client money rules. This means that any such money may be used by The Bank of New York Mellon in the course of its own business and the Issuer will rank only as a general creditor of the Custodian as regards such money. Accordingly, any investor in the Notes will be exposed to the credit risk of the Custodian insofar as the Charged Assets comprise cash.

Order of Priority on Enforcement of Security

On an enforcement of the security in respect of the Notes as referred to above, the Trustee will apply the realisation proceeds of the Mortgaged Property in accordance with Swap Counterparty Priority, which provides for the following order of priority:

- 1. payment of the fees, costs, charges, expenses, liabilities and legal fees of the Trustee and payment to the Issuer of the Series Minimum Profit (to the extent not already received by the Issuer);
- 2. payment of the fees, expenses or other amounts payable to the Custodian and/or the Principal Paying Agent or, as the case may be, the Registrar by the Issuer (including but not limited to any amounts of value added tax or other taxes due to any applicable revenue authorities) and any claim for reimbursement in respect of payment of any amount in respect of the Charged Assets made to the Swap Counterparty, or payments in respect of the Charged Agreement payable by the Swap Counterparty, prior to receipt of the same by the Custodian or the Principal Paying Agent or, as the case may be, the Registrar, as applicable, under the Custody Agreement and/or the Agency Agreement, as applicable, pari passu and rateably;
- 3. payment of any amount due to the Swap Counterparty under the Charged Agreement in respect of the termination of the Charged Agreement (excluding the claims (if any) of the Swap Counterparty as Transferor in respect of the Undelivered Charged Assets);
- 4. payment of the amounts due to the holders of the Notes *pari passu* and rateably; and
- 5. payment of the balance (if any) to the Issuer.

The ability of Noteholders to recover an amount at least equal to the Aggregate Nominal Amount of the Notes and accrued but unpaid interest is therefore dependent (*inter alia*) on there being no termination payment (if any) payable to the Swap Counterparty under the Charged Agreement.

Exposure to UBS AG

The Notes do not represent a claim against the Swap Counterparty or any affiliate of the Swap Counterparty and, in the event of any loss, Noteholders will have recourse to the proceeds of the Mortgaged Property and not to the Swap Counterparty. However, any investor in the Notes will be exposed to the credit risk of the Swap Counterparty.

Legality of Purchase

None of the Issuer, the Trustee, UBS, the Custodian, the Principal Paying Agent, the Registrar nor any other person acting on their behalf has or assumes responsibility for the lawfulness of the acquisition of the Notes by a prospective purchaser of the Notes, whether under the laws of the jurisdiction of its incorporation or the jurisdiction in which it operates (if different), or for compliance by that prospective purchaser with any law, regulation or regulatory policy applicable to it.

No Reliance

Each of the Issuer, the Trustee, UBS, the Custodian, the Principal Paying Agent and the Registrar disclaim any responsibility to advise purchasers of the Notes of the risks and investment considerations associated with the purchase of the Notes as they may exist at the date hereof or from time to time hereafter. All information (if any) relating to the Collateral Obligations has been extracted from publicly available sources. None of the Issuer, the Trustee, UBS nor any other person acting on their behalf has verified such information and, accordingly, none of them makes any representation or warranty, express or implied, as to its accuracy or completeness. Noteholders may not at any time rely on any such persons or any affiliate of any of them or any person on their behalf to monitor whether or not a default in relation to the Collateral Obligations, or an event or circumstances which, with the giving of notice, the passage of time or making of any determination, could constitute a default in relation to the Collateral Obligations, has occurred.

No Restrictions on Activities

Any of the Issuer, the Trustee, UBS, the Custodian, the Principal Paying Agent and the Registrar and any other person acting on their behalf may have existing or future business relationships (including depository, lending, advisory or any other kind of commercial or investment banking activities or other business) with the issuers of the Collateral Obligations or the Swap Counterparty or with any affiliate of the same or any other entity having obligations relating to any of the foregoing parties (including, in each case, arising from any notes issued by, to or in respect of the obligations of, any such party) and may purchase, sell or otherwise deal in any assets or obligations of, or relating to, any such party. Any of the Issuer, the Trustee and UBS or any other person acting on their behalf may act with respect to any such business, assets or obligations without regard to any possible consequences for the issuers of the Collateral Obligations or the Swap Counterparty, the Notes or the Noteholders (or the impact of any such dealing on the interests of any Noteholder) or otherwise (including, without limitation, any action which might constitute or give rise to a default in relation to the Collateral Obligations or a default or an early redemption event in respect of the Notes).

No disclosure of information: disclosure of confidential information

The Issuer or UBS may, whether by virtue of the types of relationships described herein or otherwise, at any time, be in possession of information in relation to the Collateral Obligations or their issuers or the Swap Counterparty that is or may be material in the context of the issue of the Notes and that may or may not be publicly available or known to the Noteholder, and the Notes do not create any obligation on the part of the Issuer or UBS or any other person to

disclose to any Noteholder any such relationship or information (whether or not confidential).

Taxation

Each Noteholder will assume and be solely responsible for any and all taxes of any jurisdiction or governmental or regulatory authority, including, without limitation, any state or local taxes or other like assessment or charges, that may be applicable to any payment to it in respect of the Notes. Neither the Issuer nor any other person will pay any additional amounts to the Noteholders to reimburse them for any tax, assessment or charge required to be withheld or deducted from payments in respect of the Notes by the Issuer or by the Registrar, although such requirement will give rise to an obligation to redeem the Notes early in the circumstances described in Condition 7(c) and item 22 of the Terms of the Notes. In such circumstances, Noteholders may receive an amount which is less than the Aggregate Nominal Amount of the Notes.

US Foreign Account Tax Compliance Withholding

TO ENSURE COMPLIANCE WITH IRS CIRCULAR 230, EACH TAXPAYER IS HEREBY NOTIFIED THAT: (A) ANY TAX DISCUSSION HEREIN IS NOT INTENDED OR WRITTEN TO BE USED, AND CANNOT BE USED BY THE TAXPAYER FOR THE PURPOSE OF AVOIDING U.S. FEDERAL INCOME TAX PENALTIES THAT MAY BE IMPOSED ON THE TAXPAYER; (B) ANY SUCH TAX DISCUSSION WAS WRITTEN TO SUPPORT THE PROMOTION OR MARKETING OF THE TRANSACTIONS OR MATTERS ADDRESSED HEREIN; AND (C) THE TAXPAYER SHOULD SEEK ADVICE BASED ON THE TAXPAYER'S PARTICULAR CIRCUMSTANCES FROM AN INDEPENDENT TAX ADVISER.

Pursuant to certain provisions of the U.S. Internal Revenue Code of 1986, commonly known as FATCA, a "foreign financial institution" may be required to withhold on certain payments it makes ("foreign passthru payments") to persons that fail to meet certain certification, reporting or related requirements. The Issuer has registered with the U.S. Internal Revenue Service as a reporting foreign financial institution for these purposes.

A number of jurisdictions (including the Netherlands) have entered into, or have agreed in substance to, intergovernmental agreements with the United States to implement FATCA ("IGAs"), which modify the way in which FATCA applies in their jurisdictions. Under the provisions of IGAs as currently in effect, a foreign financial institution in an IGA jurisdiction would generally not be required to withhold under FATCA or an IGA from payments that it makes. Certain aspects of the application of the FATCA provisions and IGAs to instruments such as the Notes, including whether withholding would ever be required pursuant to FATCA or an IGA with respect to payments on instruments such as the Notes, are uncertain and may be subject to change.

Even if withholding would be required pursuant to FATCA or an IGA with respect to payments on instruments such as the Notes, such withholding would not apply prior to 01 January 2019 and Notes issued on or prior to the date that is six months after the date on which final regulations defining "foreign passthru payments" are filed with the U.S. Federal Register generally would be "grandfathered" for purposes of FATCA withholding unless materially modified after such date (including by reason of a substitution of the issuer) and/or characterised as equity for U.S. tax purposes. However, if additional notes (as described under "Terms and Conditions – Further Issues" in the Programme Memorandum) that are not distinguishable from previously issued Notes are issued after the expiration of the grandfathering period and are subject to withholding under FATCA, then withholding agents may treat all such Notes, including those Notes offered prior to the expiration of the grandfathering period, as subject to withholding under FATCA.

Holders should consult their own tax advisors regarding how these rules may apply to their investment in the Notes. In the event that any withholding would be required pursuant to FATCA or an IGA with respect to payments on the Notes, no person will be required to pay additional amounts as a result of the withholding.

THE FATCA PROVISIONS ARE PARTICULARLY COMPLEX AND THEIR APPLICATION TO THE ISSUER IS UNCERTAIN AT THIS TIME. The UK's EU Referendum

Pursuant to the European Referendum Act 2015, a referendum on the United Kingdom's membership of the EU (the "**UK's EU Referendum**") was held on 23 June 2016 with the majority voting to leave the EU. On 29 March 2017, the UK Government exercised its right under Article 50 of the Lisbon Treaty to leave the EU. There is now expected to be a 2-year period of negotiations between the UK Government and the Governments of the other EU Member States which will determine the manner of the UK's departure from the EU.

Whilst the medium to long-term consequences of the decision to leave the EU remain uncertain, there could be short-term volatility which could have a negative impact on general economic conditions in the UK and business and consumer confidence in the UK, which may in turn have a negative impact elsewhere in the EU and more widely. The longer-term consequences may be affected by the length of time it takes for the UK to leave the EU and the terms of any future arrangements the UK has with the remaining member states of the EU. Among other things, the UK's decision to leave the EU could lead to instability in the foreign exchange markets, including volatility in the value of the pound sterling or the euro.

Deteriorating business, consumer or investor confidence could lead to (i) reduced levels of business activity; (ii) higher levels of default rates and impairment; and (iii) mark to market losses in trading portfolios resulting from changes in credit ratings, share prices and solvency of counterparties.

No assurance can be given that such matters would not adversely affect the market value and/or the liquidity of the Notes in the secondary market and/or the ability of the Issuer to satisfy its obligations under the Notes.

Section 871(m)

Section 871(m) of the US Tax Code requires withholding (up to 30%, depending on whether a treaty applies) on certain financial instruments to the extent that the payments or deemed payments on the financial instruments are contingent upon or determined by reference to U.S.-source dividends. Under U.S. Treasury Department regulations, certain payments or deemed payments to non-U.S. holders with respect to certain equity-linked instruments ("specified ELIs") that reference U.S. stocks may be treated as dividend equivalents that are subject to U.S. withholding tax at a rate of 30% (or lower treaty rate). Under these regulations, withholding may be required even in the absence of any actual dividend-related payment or adjustment made pursuant to the terms of the instrument. The Issuer is solely required to determine whether an issuance is subject to Section 871(m) and the regulations thereunder.

Legal Opinions

Whilst legal opinions relating to the issue of the Notes have been obtained with respect to English law and Dutch law, no such opinions have been obtained with respect to any other applicable laws, including the laws governing any Collateral Obligations or the laws of the country in which the issuers of the Collateral Obligations are incorporated or operate (if different) or as to the validity, enforceability or binding nature of the Collateral Obligations as against the obligors thereof or of the Charged Agreement as against the Swap Counterparty.

Limited Recourse

The Notes are limited recourse obligations of the Issuer and are payable solely from the proceeds of the Mortgaged Property. The holders of the Notes will have no right to proceed directly against the obligors in respect of the Mortgaged Property. The Notes do not represent obligations of, nor are they insured or guaranteed by the Trustee, the Swap Counterparty, the Arranger, the Custodian, the Calculation Agent, the Registrar or any of their respective affiliates. None of the Trustee, the Swap Counterparty, the Arranger, the Custodian, the Calculation Agent, the Principal Paying Agent, the Registrar or any of their respective owners, beneficiaries, agents, officers, directors, employees, affiliates, successors or assigns will, in the absence of an express agreement to the contrary or as otherwise provided by law, be obliged to make payments in respect of the Notes. If distributions on such Mortgaged Property are insufficient to make payments on the Notes, no other assets will be available for payment of the deficiency and, following realisation of the Mortgaged Property, no debt shall be owed in respect of any such deficiency.

Considerations regarding increased regulation

The financial markets are encountering the increased involvement of governmental and regulatory authorities in the financial sector and in the operation of financial institutions and products offered and/or arranged by them. In particular, governmental and regulatory authorities in a number of jurisdictions have imposed stricter regulatory controls around certain financial activities and/or have indicated that they intend to impose such controls in the future. The United States of America, the European Union and other jurisdictions are actively considering or are in the process of implementing various reform measures covering, among other things, derivative transactions and the offering of structured products and other financial investments and instruments. Accordingly, no assurance can be given as to the consequences for any investor on their investment in Notes as a result of such regulatory developments and/or as a result of any compliance or lack of compliance by such party in respect of the same.

Capital loss risk

The Cash Collateral and the Collateral Obligations shall together comprise the "Collateral Assets".

For the avoidance of doubt, no Collateral Obligations shall be required to be removed from the Collateral Account or otherwise replaced in the event that such Collateral Obligations are downgraded by any rating agency such that the rating assigned to such Collateral Obligations is lower than the rating assigned to such Collateral Obligations at the time they first formed part of the Charged Assets.

On each calendar day except a Monthly Valuation Date (as defined below) (or the next following Business Day if such day is not a Business Day) (each such day or, as the case may be, each such next following Business Day, a "Daily Valuation Date") from and including the Daily Valuation Date immediately following the Original Issue Date to and including the Daily Valuation Date immediately prior to the latest Maturity Date to occur in respect of the Notes, the Calculation Agent shall determine (i) the aggregate Market Value of the Collateral Assets and (ii) the aggregate Market Value of the Collateral Assets which would be obtained if any applicable Haircut was zero (the "Pre-Haircut Market Value") and notify the Issuer, the Collateral Agent and the Swap Counterparty whether and the extent to which the aggregate Pre-Haircut Market Value of the Collateral Assets is less than the Series 229 Amount on such date (a date on which the aggregate Pre-Haircut Market Value of the Collateral Assets is determined as being less than the Series 229 Amount, being a "Daily Rebalancing Date").

- 48. If the aggregate Pre-Haircut Market Value of the Collateral Assets on a Daily Rebalancing Date is less than the Series 229 Amount on such date, the Swap Counterparty shall give instructions pursuant to the Swap Confirmation (to the extent such instructions have not been given pursuant to the Original Confirmation and/or the Second Confirmation and/or the Third Confirmation and/or the Fourth Confirmation and/or the Fifth Confirmation and/or the Sixth Confirmation and/or the Seventh Confirmation and/or the Eighth Confirmation and/or the Ninth Confirmation and/or the Tenth Confirmation) and the Collateral Agent shall, in accordance with such instructions, effect a Substitution on or prior to the second Business Day following the Daily Rebalancing Date, so that, immediately following such Substitution, the aggregate Market Value of the Collateral Assets is equal to or greater than the Series 229 Amount on such date.
- 50. For the purpose of determining whether any adjustment to the Collateral Assets is required or permitted pursuant to this Special Condition (I)(A), (i) the aggregate Market Value of the Collateral Assets and (ii) the aggregate Pre-Haircut Market Value of the Collateral Assets, as of the Daily Valuation Date, shall be calculated taking into account any prior Substitution or Release which is due to be effected but for which the relevant settlement date falls on or after such Daily Valuation Date.
- 51. If the aggregate Market Value of the Collateral Assets on a Monthly Valuation Date is equal to or greater than the Series 229 Amount on such date, the Swap Counterparty may give instructions pursuant to the Swap Confirmation and the Collateral Agent shall, where instructions are so given and in accordance with such instructions, effect a Substitution and/or a Release on or prior to the fifth Business Day following such Monthly Valuation Date, provided that immediately following any such Substitution and/or Release, the aggregate Market Value of the Collateral Assets is equal to or greater than the Series 229 Amount on such date. For the avoidance of doubt, the aggregate Market Value of the Collateral Assets immediately following such Substitution and/or Release may be less than the aggregate Market Value of the Collateral Assets on that Monthly Valuation Date (other than in the event that the aggregate Market Value of the Collateral Assets on the Monthly Valuation Date is equal to the Series 229 Amount on such date).
- 54. If the aggregate Market Value of the Collateral Assets on a Monthly Rebalancing Date is less than the Series 229 Amount on such date, the Swap Counterparty shall give instructions pursuant to the Swap Confirmation (to the extent such instructions have not been given pursuant to the Original Confirmation and/or the Second Confirmation and/or the Third Confirmation and/or the Fourth Confirmation and/or the Fifth Confirmation and/or the Sixth Confirmation and/or the Seventh Confirmation and/or the Eighth Confirmation and/or the Ninth Confirmation and/or the Tenth Confirmation) and the Collateral Agent shall, in accordance with such instructions, effect a Substitution on or prior to the second Business Day following the Monthly Rebalancing Date, so that, immediately following such Substitution, the aggregate Market Value of the Collateral Assets is equal to or greater than the Series 229 Amount on such date.
- 55. For the purpose of determining whether any adjustment to the Collateral Assets is required or permitted pursuant to this Special Condition (I)(B), the aggregate Market Value of the Collateral Assets as of the Monthly Valuation Date shall be calculated taking into account any prior Substitution or Release which is due to be effected but for which the relevant settlement date falls on or after such Monthly Valuation Date.
- 56. Notwithstanding the provisions of this Special Condition (I)(B), if a Substitution Effective Date or Release Date relating to a Monthly Valuation Date (including, without limitation, a Monthly Rebalancing Date) would otherwise fall on or after the latest Maturity Date to occur in respect of the Notes or any other due date for redemption of all of the outstanding Notes, none of the Issuer, the Swap Counterparty nor the Collateral Agent shall have any obligation to effect such Substitution or Release relating thereto.

(C) Definitions

For the purposes of this Special Condition (I), the following terms shall have the meaning set out below:-

"Haircut" means, in relation to any Collateral Obligations, 5 per cent.

"Market Value" means:

(i) in relation to Cash Collateral in USD, such amount of cash, and in relation to Cash Collateral in any other currency, the amount of such currency converted into USD at the prevailing applicable spot exchange rate, as determined by the Calculation Agent in its sole and absolute discretion; and

(ii) in relation to Collateral Obligations, the market value of such Collateral Obligations determined by the Calculation Agent in a commercially reasonable manner and converted, as necessary, into USD at the prevailing applicable spot exchange rate as determined by the Calculation Agent in its sole and absolute discretion multiplied by the result of (x) 100% minus (y) the applicable Haircut.

(II) (A) Substitution of Collateral Assets

57. The Collateral Agent shall (acting as agent for the Issuer) effect each Substitution in accordance with the instructions of the Swap Counterparty given pursuant to the Swap Confirmation (to the extent such Substitution has not been effected in accordance with the instructions of the Swap Counterparty given pursuant to the Original Confirmation and/or the Second Confirmation and/or the Third Confirmation and/or the Fourth Confirmation and/or the Fifth Confirmation and/or the Sixth Confirmation and/or the Seventh Confirmation and/or the Eighth Confirmation and/or the Ninth Confirmation and/or the Tenth Confirmation).

A "Substitution" shall comprise:

- (a) a sale of any of the Collateral Obligations to any party (including the Swap Counterparty); and/or
- (b) the transfer of any of the Cash Collateral to any party (including the Swap Counterparty); and/or
- (c) a purchase of any Eligible Collateral Obligations from any party (including the Swap Counterparty); and/or
- (d) the transfer of any Eligible Cash Collateral from any party (including the Swap Counterparty),

provided that the effect of the foregoing shall not cause the aggregate Market Value of the Collateral Assets immediately following the Substitution, as determined by the Calculation Agent, to be less than the Series 229 Amount at such time.

The Collateral Assets referred to in (a) and (b) above are "Substituted Collateral Assets" and the Eligible Collateral Obligations and the Eligible Cash Collateral referred to in (c) and (d) above are "Substitute Collateral Assets".

58. The date on which a Substitution is effected is the "**Substitution Effective Date**". The Substitution Effective Date shall be specified by the Swap Counterparty pursuant to the Swap Confirmation, which shall be a date that is not less than two Business Days from the date that such instructions are given by the Swap Counterparty.

- 59. The Collateral Agent shall procure that upon any release of the Substituted Collateral Assets from the security created by or pursuant to the Constituting Instrument, any Substitute Collateral Assets being substituted for the Substituted Collateral Assets shall be delivered, transferred or assigned to the Custodian (on behalf of the Issuer) with full title guarantee and subject to the charge or other security interest created by or pursuant to the Constituting Instrument. The Collateral Agent shall also procure that the delivery, transfer or assignment of the Substitute Collateral Assets to the Custodian (on behalf of the Issuer), or of the Substituted Collateral Assets by the Custodian (on behalf of the Issuer) to any party, would not require or cause the Issuer to assume, and would not subject the Issuer to, any obligation or liability (other than immaterial, non-payment obligations).
- 60. Notwithstanding the foregoing, any Substitution shall be subject to compliance with all relevant laws, regulations and directives, to the terms of the Substituted Collateral Assets and the Substitute Collateral Assets and to the Swap Counterparty paying any costs and expenses (including, without limitation, any stamp duty or other tax) payable in connection with such Substitution.
- 61. The Trustee shall not be liable to the Issuer, the Noteholders or any other person, nor shall the Issuer be liable to the Trustee, any Noteholder or any other person, for any loss arising from any arrangement referred to or otherwise arising from the operation of this Special Condition (II)(A).

(B) Release of Collateral Assets

62. The Collateral Agent shall (acting as agent for the Issuer) effect each Release in accordance with the instructions of the Swap Counterparty given pursuant to the Swap Confirmation (to the extent such Release has not been effected in accordance with the instructions of the Swap Counterparty given pursuant to the Original Confirmation and/or the Second Confirmation and/or the Third Confirmation and/or the Fourth Confirmation and/or the Fifth Confirmation and/or the Sixth Confirmation and/or the Seventh Confirmation and/or the Eighth Confirmation and/or the Ninth Confirmation and/or the Tenth Confirmation).

A "Release" shall comprise:

- (a) a transfer of any of the Collateral Obligations to any party (including the Swap Counterparty); and/or
- (b) the transfer of any of the Cash Collateral to any party (including the Swap Counterparty),

provided that the effect of the foregoing shall not cause the aggregate Market Value of the Collateral Assets immediately following the Release, as determined by the Calculation Agent, to be less than the Series 229 Amount at such time.

The Collateral Assets referred to in (a) and (b) above are "Released Collateral Assets".

The date on which a Release is effected is the "**Release Date**". The Release Date shall be specified by the Swap Counterparty pursuant to the Swap Confirmation, which shall be a date that is not less than two Business Days from the date that such instructions are given by the Swap Counterparty.

- 63. The Collateral Agent shall procure that the delivery, transfer or assignment of the Released Collateral Assets by the Custodian (on behalf of the Issuer) to any party would not require or cause the Issuer to assume, and would not subject the Issuer to, any obligation or liability (other than immaterial, non-payment obligations).
- 64. Notwithstanding the foregoing, any Release shall be subject to compliance with all relevant laws, regulations and directives, to the terms of the Released Collateral Assets and to the Swap Counterparty paying any costs and expenses (including, without limitation, any stamp duty or other tax) payable in connection with such Release.
- 65. The Trustee shall not be liable to the Issuer, the Noteholders or any other person, nor shall the Issuer be liable to the Trustee, any Noteholder or any other person, for any loss arising from any arrangement referred to or otherwise arising from the operation of this Special Condition (II)(B).

(III) Calculations, Determinations and Notifications

- 66. Any determination by the Calculation Agent or exercise of discretion shall be made by the Calculation Agent in good faith, in a commercially reasonable manner and shall be binding on the Issuer, the Noteholders, the Swap Counterparty, the Principal Paying Agent, the Custodian and the Trustee in the absence of manifest error.
- 67. If the Calculation Agent does not at any time for any reason calculate and determine any amount or thing which falls to be calculated and/or determined, or perform any duty which falls to be performed by it, pursuant to the Terms of the Notes, the Trustee (or a person appointed by it for that purpose) shall (subject to it being indemnified and/or secured and/or prefunded to its satisfaction) do so and such determination and calculation or performance shall be deemed to have been made by the Calculation Agent. In doing so, the Trustee shall apply the provisions of the Terms of the Notes, with any necessary consequential amendments, to the extent that, in its opinion, it is able to do so and, in all other respects, it shall do so in such manner as it shall deem fair and reasonable in all circumstances. The Trustee shall have no liability to any person in connection with any determination or calculation it is required to make pursuant to this Special Condition (III).
- 68. None of the Issuer, the Calculation Agent, the Swap Counterparty, the Custodian, the Registrar, the Calculation Agent, the Principal Paying Agent, the Collateral Agent or the Trustee shall have any duty or responsibility to investigate or check whether any default in respect of the Charged Assets has occurred (but without prejudice to any obligation of the Calculation Agent to determine the Market Value of the Collateral Assets pursuant to Special Condition (I) or Special Condition (II)) nor shall any of such persons (excluding the Swap Counterparty) have any duty or responsibility to investigate or check whether any UBS Default Event has occurred.
- 69. Each of the Issuer, the Swap Counterparty, the Collateral Agent, the Principal Paying Agent, the Custodian, the Registrar and the Trustee shall be entitled to rely on any certification, notification, calculation or determination of the Calculation Agent given or copied to it as being true and accurate for all purposes and none of them shall be obliged to make any investigation or enquiry into any such certification, notification, calculation or determination or into the basis on which such certification, notification, calculation or determination was prepared, given or made.

(IV) Voting Rights

70. Unless a UBS Default Event has occurred and such UBS Default Event is continuing. Condition 13(b) shall be amended in relation to the Notes by the deletion of the words "or by an Extraordinary Resolution of the Noteholders" and the words "or directed by an Extraordinary Resolution of the Noteholders" and by their replacement with the words "or the Swap Counterparty" and the Trustee shall not exercise any rights in respect of the Charged Assets pursuant to Condition 13(b) without the prior written consent of the Swap Counterparty. The Swap Counterparty or the Trustee may direct the Custodian to, and the Custodian shall, exercise any such rights (at the cost of the Swap Counterparty) in such manner as the Swap Counterparty or the Trustee, as the case may be, may direct subject always (for the avoidance of any doubt) to the sentence of Condition 13(b) (as amended) commencing with the words "If any such persons aforesaid". The Swap Counterparty or the Trustee shall promptly notify the Issuer and the Trustee or the Swap Counterparty, as the case may be, of any such directions so given. In addition to the foregoing, Condition 13(b) shall be amended by the deletion of the words "Notwithstanding the foregoing, if the Swap Counterparty is expressed to rank ahead of the Noteholders pursuant to Condition 4(d) and if any sum of money is or may become due to the Swap Counterparty pursuant to the Charged Agreement, the Issuer shall not act in accordance with the directions of the Trustee or of the Noteholders given as aforesaid in relation to the Charged Assets without the Issuer obtaining the prior written consent of the Swap Counterparty.".

(V) Priority

71. Condition 4(d)(1) shall be deleted in its entirety and replaced by the following:

"(1) "Swap Counterparty Priority" means:

- (i) first, in meeting any claim of the Custodian and/or the Principal Paying Agent or, as the case may be, the Registrar, *pari passu* and rateably, under the Custody Agreement and the Agency Agreement, respectively, in respect of any fees, expenses or other amounts payable by the Issuer (including but not limited to any amounts of value added tax or other taxes due to any applicable revenue authorities) and any claim for reimbursement in respect of payment of any amount in respect of the Charged Assets made to the Swap Counterparty, or payments in respect of the Charged Agreement payable by the Swap Counterparty, prior to receipt of the same by the Custodian or the Principal Paying Agent or, as the case may be, the Registrar, as applicable;
- (ii) secondly, in meeting the claims (if any) of the Swap Counterparty under the Charged Agreement (excluding the claims (if any) of the Swap Counterparty as Transferor in respect of the Undelivered Charged Assets):
- (iii) thirdly, in meeting the claims (if any) of the Noteholders, the Receiptholders and the Couponholders (if any) in respect of the Notes on a *pari passu* basis; and
- (iv) fourthly, in payment of the balance (if any) to the Issuer;".

(VI) Discharge of Issuer's Obligations

72. Following the occurrence of a Relevant Early Redemption Event, upon any payment in full of the Relevant Early Redemption Amount in respect of the Notes on the Relevant Early Redemption Date, the Issuer's obligations under the Notes shall be cancelled and discharged in full (and, without limitation to the generality of the foregoing, the Issuer shall have no obligation to make payment of the Aggregate Nominal Amount of the Notes or any interest thereon) and the Noteholders in respect of the Notes shall have no further recourse to the Issuer or any other party in respect of the Notes.

(VII) Delivery of Charged Assets to the Swap Counterparty

73. Following the occurrence of a Relevant Early Redemption Event, the Issuer shall deliver or procure the delivery of all of the Collateral Assets to or to the order of the Swap Counterparty in accordance with the terms of the Charged Agreement. The security constituted by the Trust Deed over the Collateral Assets shall be released upon delivery of the Collateral Assets to or to the order of the Swap Counterparty.

(VIII) Securities Transaction Tax relating to Transfer of Charged Assets

74. If, as a result of the transfer of any Collateral Assets to the Swap Counterparty, the Issuer shall be obliged to pay any securities transaction tax in relation to such transfer of such Collateral Assets, the Swap Counterparty shall pay to or to the order of the Issuer an amount equal to the amount of such tax free from any withholding or deduction.

(IX) Duties of Calculation Agent

75. The Calculation Agent has undertaken in the Agency Agreement (as amended, modified and supplemented) to make the calculations, to perform the duties and to give, or (as applicable) procure the giving of, the notices required to be given by it pursuant to the Terms and Conditions of the Notes.

(X) Redemption following Breach of Selling Restrictions

76. Condition 7(b)(5) shall not apply and the following shall apply in its place:

"If the Notes are sold or otherwise transferred to any person in breach of: (i) any applicable restrictions on sale of securities; and/or (ii) any restrictions, rules and/or regulations which are applicable to the sale of securities to US Persons (as defined in Regulation S under the United States Securities Act of 1933, as amended) or to any person other than Non-United States Persons (as defined by the United States Commodity Futures Trading Commission) (in each case as determined by the Arranger in its sole and absolute discretion with regards or by reference to the facts and circumstances then existing) (such Notes the "Affected Notes"), the Issuer shall, if instructed to do so by the Arranger, redeem the Affected Notes sold to that person on the date notified by the Arranger to the Issuer for such purpose (the "Sale Restriction Redemption Date"). On the Sale Restriction Redemption Date, the Affected Notes shall be redeemed in the same manner as if such Sale Restriction Redemption Date were an Early Redemption Date (and in this regard the provisions of item 22 shall apply mutatis mutandis) (such amount payable the "Sale Restriction Redemption Amount"). No further amounts will be due to such Noteholders after payment of the Sale Restriction Redemption Amount.".

(XI) Maturity Extension Provision

- 77. No later than 45 calendar days prior to the then existing Maturity Date (save for the Final Extended Maturity Date), the Calculation Agent shall deliver a notice to the Swap Counterparty and, on behalf of the Issuer, via the clearing systems, to the Noteholders, to request (a) an extension of three months of the then existing Maturity Date (such existing Maturity Date a "Current Maturity Date") (the resulting Maturity Date, as so extended from the Current Maturity Date being an "Extended Maturity Date"), and (b) to amend the then existing Spread for the purposes of calculating the Interest Rate (such existing Spread the "Current Spread") (the resulting Spread, as so amended from the Current Spread being an "Revised Spread"), (such notice, a "Extension Request Notice" and such amendments to the Maturity Date and Spread, the "Proposed Amendments"). Pursuant to the foregoing, (i) the first Extended Maturity Date is scheduled to fall on 14 May 2017, (ii) the second Extended Maturity Date is scheduled to fall on 14 August 2017, (iii) the third Extended Maturity Date is scheduled to fall on 14 November 2017, (iv) the fourth Extended Maturity Date is scheduled to fall on 14 February 2018, (v) the fifth Extended Maturity Date is scheduled to fall on 14 May 2018, (vi) the sixth Extended Maturity Date is scheduled to fall on 14 August 2018, (vii) the seventh Extended Maturity Date is scheduled to fall on 14 November 2018, (viii) the eighth Extended Maturity Date is scheduled to fall on 14 February 2019. (ix) the ninth Extended Maturity Date is scheduled to fall on 14 May 2019, (x) the tenth Extended Maturity Date is scheduled to fall on 14 August 2019 and (xi) the eleventh Extended Maturity Date is scheduled to fall on the Final Extended Maturity Date (being 14 November 2019).
- 78. The Swap Counterparty and each Noteholder shall, on or prior to the day falling 35 calendar days prior to Current Maturity Date (the "Extension Request Cut-off Date") be entitled to consent to or reject the request for such Proposed Amendments. Any such consent given by the Swap Counterparty shall be given by way of notice from the Swap Counterparty to the Issuer, the Trustee and each Agent. Any such consent given by a Noteholder (or, in accordance with paragraph 82 below, is deemed to give such consent) (an "Extending Noteholder" in respect of (a) the extension of the applicable Maturity Date and (b) the applicable Spread, in each case to which such consent relates) shall be given via the clearing systems, to the Issuer, copied to the Trustee and the Agents.
- 79. Where the Swap Counterparty consents (or, in accordance with paragraph 82 below, is deemed to consent) to the Proposed Amendments, then (x) the Maturity Date in respect of the Notes of each Extending Noteholder shall be extended from the applicable Current Maturity Date to the related Extended Maturity Date (subject to adjustment in accordance with the Business Day Convention) and (y) from and including the applicable Current Maturity Date, the Spread in respect of such Notes of each Extending Noteholder shall be amended from the applicable Current Spread to the related Revised Spread.
- 80. Where the Swap Counterparty rejects the Proposed Amendments, then notwithstanding that there may be any Extending Noteholders in respect of such Proposed Amendments, all the outstanding Notes shall be redeemed on the applicable Current Maturity Date (each outstanding Notes, in such circumstances, being a "Non-Extended Maturity Note") at their Scheduled Redemption Amount.

- 81. Where any Noteholder is not an Extending Noteholder in respect of the Proposed Amendments, the Current Maturity Date of the Notes of such Noteholder (each such Note of such Noteholder being, in such circumstances, a "Non-Extended Maturity Note") shall not extend and the Spread shall not be amended and each Non-Extended Maturity Note shall be redeemed on the applicable Current Maturity Date at its Scheduled Redemption Amount.
- 82. Where the Swap Counterparty or any Noteholder fails to respond to an Extension Request Notice by the applicable Extension Request Cut-off Date, the Swap Counterparty or such Noteholder, as applicable, shall be deemed to have duly consented to the Proposed Amendments by the applicable Extension Request Cut-off Date (and, for the avoidance of doubt, in the case of such Noteholder, such Noteholder shall be treated as an Extending Noteholder).
- 83. The Maturity Date of the Notes cannot be extended beyond the Final Extended Maturity Date.

The purpose of this letter agreement is to set out the terms and conditions of the Asset Swap Transaction (as defined below) entered into between us on the Trade Date specified below (the "Swap Transaction"). This letter agreement constitutes a "Confirmation" as referred to in the Agreement (as defined below). References in this letter agreement to (i) the "Original Confirmation" means the swap confirmation entered into dated 14 November 2016; (ii) the "Second Confirmation" means the swap confirmation entered into dated 25 November 2016; (iii) the "Third Confirmation" means the swap confirmation entered into dated 12 January 2017; (iv) the "Fourth Confirmation" means the swap confirmation entered into dated 22 February 2017; (vi) the "Sixth Confirmation" means the swap confirmation entered into dated 22 February 2017; (vii) the "Seventh Confirmation" means the swap confirmation entered into dated 16 March 2017; (viii) the "Eighth Confirmation" means the swap confirmation entered into dated 22 March 2017; (vii) the "Eighth Confirmation" means the swap confirmation entered into dated 3 April 2017; (ix) the "Ninth Confirmation" means the swap confirmation entered into dated 12 April 2017; and (x) the "Tenth Confirmation" means the swap confirmation entered into dated 27 April 2017 each of which is entered into in connection with the Existing Notes.

Words and expressions used, but not otherwise defined herein, shall have the same meaning ascribed to them (or incorporated by reference) in the Terms and Conditions of ELM's Series 229 USD 66,400,000 Extendable Secured Floating Rate Notes due 2018 (the "Further Notes") to be consolidated and form a single Series with the existing USD 353,900,000 Extendable Secured Floating Rate Notes due 2018 (the "Existing Notes" and together with the Further Notes, the "Notes").

In connection with the foregoing, this Confirmation sets out the terms of an asset swap transaction in respect of the Notes (the "**Asset Swap Transaction**").

The definitions and provisions contained in the 2006 ISDA Definitions (as published by the International Swaps and Derivatives Association, Inc.) are incorporated into this Confirmation. In the event of any inconsistency between those definitions and provisions and this Confirmation, this Confirmation will prevail.

1. **Swap Agreement**

This Confirmation supplements, forms part of, and is subject to, the Swap Agreement relating to the Notes dated as of today's date between us and you (as the same may be amended or supplemented from time to time, the "Agreement"). All provisions contained in the Agreement govern this Confirmation except as expressly modified below.

- (C) UBS and ELM agree that if on any Daily Valuation Date or on any Monthly Valuation Date, the Calculation Agent under the Notes has determined that the aggregate Market Value of the Collateral Assets is equal to or greater than the Series 229 Amount on such date, then, in each case, UBS may give instructions in accordance with paragraph (A) above and/or Other Provision 3 below with respect to a Substitution and/or Release, specifying a Substitution Effective Date and/or Release

Date which shall be no later than the fifth Business Day following such Daily Valuation Date or such Monthly Valuation Date, as the case may be, provided that, immediately following such Substitution and/or Release, the aggregate Market Value of the Collateral Assets is equal to or greater than the Series 229 Amount at such time.

- (i) specify the Release Date (for the avoidance of doubt, the Release Date shall be a date that is not less than two Business Days from the date that such instructions are given by UBS);
- (ii) specify the relevant Released Collateral Assets; and

UBS and ELM hereby agree that, provided that a UBS Default Event has not occurred, to the extent that any rights become exercisable in connection with the Collateral Obligations, UBS may (at its own cost) direct the Custodian to exercise any such rights in such manner as UBS may direct subject always (for the avoidance of any doubt) to the sentence of Condition 13(b) (as amended) commencing with the words "If any such persons aforesaid". UBS shall promptly notify ELM and the Trustee of any such directions so given.

5. **Breach of Selling Restrictions**

Upon termination of the Swap Transaction in whole or in part as a result of a breach of any selling restrictions in respect of the Notes (pursuant to paragraph 6.1 of the Constituting Instrument), then the early termination amount in respect of the Swap Transaction shall not be determined in accordance with Section 6(e) of the Agreement and, instead:

- (i) UBS shall pay to ELM an amount equal to the aggregate Sale Restriction Redemption Amount due to be paid by ELM under the terms of the Notes; and
- (ii) ELM shall (provided that it is not impossible, illegal or impracticable for ELM to deliver the same, and subject to all applicable laws, regulations and directives and to the terms of the Charged Assets and subject to UBS bearing all costs and expenses (including tax) relating to the same) deliver to UBS a proportion of the Charged Assets equal to the proportion which the outstanding principal amount of the Notes being redeemed bears to the Series 229 Amount (immediately prior to such redemption).

Upon such payments and deliveries being effected, no further amounts or deliveries shall be due by either party in respect of the proportion of the Swap Transaction terminated.

6. **Maturity Extension Provision**

- (i) Pursuant to the terms of the Notes, no later than 45 calendar days prior to the then Maturity Date (save for the Final Extended Maturity Date), the Calculation Agent shall deliver an Extension Request Notice to UBS and, on behalf of ELM, via the clearing systems, to the Noteholders, to request consent for the Proposed Amendments.
- (ii) UBS and each Noteholder shall, on or prior to the Extension Request Cut-off Date, be entitled to consent to or reject the request for such Proposed Amendments. Any such consent given by UBS shall be given by way of notice from UBS to ELM, the Trustee and each Agent.
- (iii) Where UBS consents (or, in accordance with the provisions below, is deemed to consent) to the Proposed Amendments, then (x) the Maturity Date in respect of the Notes of each Extending Noteholder shall be extended from the applicable Current Maturity Date to the related Extended Maturity Date (subject to adjustment in accordance with the Business Day Convention) and the Termination Date of this Swap Transaction shall extend accordingly and (y) from and including the applicable Current Maturity Date, the Spread in respect of such Notes of each Extending Noteholder shall be amended from the applicable Current Spread to the related Revised Spread.
- (iv) Where UBS rejects the Proposed Amendments, then notwithstanding that there may be any Extending Noteholders in respect of such Proposed Amendments, all the outstanding Notes shall be redeemed on the applicable Current Maturity Date at their Scheduled Redemption Amount and, accordingly, a UBS Final Exchange Amount and an ELM Final Exchange Amount shall be due and payable on the applicable Final Exchange Date.
- (v) Where any Noteholder is not an Extending Noteholder in respect of the Proposed Amendments, the Current Maturity Date of the Notes of such Noteholder shall not extend and the Spread shall not be amended and each Non-Extended Maturity Note shall be redeemed on the applicable Current Maturity Date at its Scheduled Redemption Amount and, accordingly, a UBS Final Exchange Amount and an ELM Final Exchange Amount shall be due and payable on the applicable Final Exchange Date.
- (vi) Where UBS or any Noteholder fails to respond to an Extension Request Notice by the applicable Extension Request Cut-off Date, UBS or such Noteholder, as applicable, shall be deemed to have duly consented to the Proposed Amendments by the applicable Extension Request Cut-off Date and the Termination Date of this Swap Transaction shall extend accordingly.
- (vii) The Maturity Date of the Notes (and accordingly, the Termination Date of this Swap Transaction) cannot be extended beyond the Final Extended Maturity Date.

7. Additional Provisions

- (A) Words and expressions defined in the Terms and Conditions of the Notes shall bear the same meanings in this Confirmation and, in the event of any inconsistency between words and expressions defined in the Terms and Conditions of the Notes and words and expressions defined in this Confirmation, this Confirmation will prevail.
- (B) The Calculation Agent's calculations and determinations shall be made in good faith and in a commercially reasonable manner and shall be binding in the absence of manifest error.
- (C) UBS hereby agrees to pay, and indemnify ELM against, any costs and expenses (including, without limitation, any securities transaction tax, stamp duty or other tax) payable by ELM or incurred by ELM in connection with the delivery of any Collateral Obligations to UBS by ELM, or the Collateral Agent on behalf of ELM, or to ELM.
- (D) In calculating any amounts payable by ELM to UBS or vice versa upon the termination of the Swap Transaction it shall be assumed that the Notes and the Collateral Obligations will not be redeemed until the Maturity Date.
- (E) Following a Relevant Early Redemption Event, Section 6 of the Agreement shall be subject to the proviso that it shall only be possible for a party to designate an Early Termination Date in respect of the Swap Transaction if ELM does not effect a ELM Delivery in accordance with the terms of the Asset Swap Transaction and, in such event, UBS's Loss determined pursuant to Section 6(e) of the Agreement shall take into account (but not be limited to) any Break Costs having arisen in connection with the early termination of the Swap Transaction, as determined by the Calculation Agent in its sole and absolute discretion.
- (F) Each party agrees with the other that, so long as either party has or may have any obligation under the Swap Transaction:-
 - (i) each party, the Trustee and its affiliates may deal in any other obligations or assets of, or relating to, any issuer of the Collateral Obligations and may, where permitted, accept deposits from, make loans or otherwise extend credit to, and generally engage in any kind of commercial or investment banking or other business with any issuer of the Collateral Obligations, any affiliate of them, or any other person or entity having obligations relating to any thereof, and may act with respect to such business in the same manner as each of them would if the Swap Transaction did not exist, regardless of whether any such action might have an adverse effect on any issuer of the Collateral Obligations or the position of the other party to the Swap Transaction or otherwise; and
 - (ii) each party, the Trustee and its affiliates may, whether by virtue of the types of relationships described herein or otherwise, on the date hereof or at any time hereafter, be in possession of information in relation to the Collateral Obligations that is or may be material in the context of any Swap Transaction and that may or may not be publicly available or known to the other party. Corporate Information

The legal and commercial name of the company is UBS AG.

The company was incorporated under the name SBC AG on 28 February 1978 for an unlimited duration and entered in the Commercial Register of Canton Basel-City on that day. On 8 December 1997, the company changed its name to UBS AG. The company in its present form was created on 29 June 1998 by the merger of Union Bank of Switzerland (founded 1862) and Swiss Bank Corporation (founded 1872). UBS AG is entered in the Commercial Registers of Canton Zurich and Canton Basel-City. The registration number is CHE-101.329.561.

UBS AG is incorporated and domiciled in Switzerland and operates under the Swiss Code of Obligations as an Aktiengesellschaft, a corporation limited by shares.

The London Branch of UBS AG does not have a separate legal personality and forms a single entity with UBS AG. The London Branch of UBS AG was established on 16 June 1998.

According to article 2 of the articles of association of UBS AG dated 4 May 2016 ("Articles of Association"), the purpose of UBS AG is the operation of a bank. Its scope of operations extends to all types of banking, financial, advisory, trading and service activities in Switzerland and abroad. UBS AG may establish branches and representative offices as well as banks, finance companies and other enterprises of any kind in Switzerland and abroad, hold equity interests in these companies, and conduct their management. UBS AG is authorized to acquire, mortgage and sell real estate and building rights in Switzerland and abroad. UBS AG may borrow and invest money on the capital markets. UBS AG is part of the group of companies controlled by the group parent company UBS Group AG. It may promote the interests of the group parent company or other group companies. It may provide loans, guarantees and other kinds of financing and security for group companies.
